State Titles are on this weekend, September 15-16. We have three races, all to count, organized by the Palm Beach Sailing Club and we expect 15 starters - could go as high as twenty. We thought the timing gives us all time to get over the Christmas dinner, the first week to drive north, south, east, settle down, sniff around and then enjoy the sailing for a week. S.P.S.C. has beautiful launching areas, a camp site 100 yards from the club house, a pool for the youngsters and a complete suburban shopping arcade with Woolies is within walking distance.

Following your visit last week we are happy to confirm our earlier offer of an insurance scheme for your Association. We would suggest that it operate on an annual basis, say from 1st October, as does the TS.16 cover. The rates charged are basically the same as before but include Stamp Duty and Third Party Liability for \$100,000.

The policy is <u>free of Excess</u> the only deduction being for Mast, Spars and Sails <u>blown out whilst racing</u>. These claims will be met subject to the following deductions:-

Mast, spars & sails less than 1 year old

over 1 year but less than 2

over 2 years

Full amount claimed

deduction 15% on repairs or replacement cost. deduction 30%.

The advantages for Members entering an insurance cover such as this are:

- 1. You get the advantage of a collective policy which means cheaper rates.
- 2. You deal with a Company which is experienced in this area and whose personnel understand boats and sailing.
- 3. You do not loose your individuality and dealings are direct between you and the Underwriter both for insuring your yacht and settling claims. There is no middle man involved.
- 4. An Agency has been arranged in the name of the Association resulting in the Association receiving commission on all Members' policies. This will provide a regular source of income which will be for the benefit of all Members.

It is suggested that the Master Policy be issued from 1st October and will be renewed each year on that date. Members wishing to join the scheme can do so by paying a pro rata premium from expiry of their present policy to 1st October. A scale of premium will be prepared for Members joining during the policy year.

SUBJECT: PROPOSED NEW RIG INCORPORATING INCREASED ALLOWABLE SAIL AREA
AS DISCUSSED AT THE SANDGATE NATIONALS A.G.M. 1979.

It is proposed to allow in the forthcoming season (and State/National Titles in the 1980/81 season) that all RL24's sailing in open competition to Increase their sail area in the following manner:-

- Limit the mainsail to its approx. present plan with a maximum measured area of 13.1 sq.m.
- 2. Increase the measured total sail area to 23.0sq.m. primarily by the addition of a larger headsail to the rig for better light air performance. Overlap not to exceed 150%.
- 3. Headsail halyard height to be limited to 5,600mm above the cabin top and three headsails to be allowed while racing.
- 4. Increase the spinnaker size to 25sq.m. measured area and halyard height to be limited to 6,000mm above the cabin top and two spinnakers to be allowed while racing.

Note: RL24's with standard rigs could bring their boats up to date by the addition of a headsail of the following approx. dimensions:—

Luff 6,200mm Foot 2,400mm Leach 5,600mm
